The Bison School Board	Dear Secretary Sanderson, Upon reviewing the new proposed Social Studies standards, our teachers, school board, and administration have some issues with this document. Currently as superintendent and accessing my experience as teaching middle school social studies for 15 years, these standards at the elementary level are not age or developmentally appropriate and in some cases the amount of content is unreasonable to be addressed in those early grades. For a small district like ourselves, we would need to purchase new curriculum materials K-12 which is extremely expensive and not in our budget. There are no available textbook materials organized in this fashion and at these grade levels. There would also be training needed for our teachers to understand and teach these standards and what strategies should be used to unpack these standards into a curriculum. Teaching the proposed social studies standards at the early elementary level would take such an increased amount of time during the school day, when the majority of focus for early elementary is reading and math. In the upper grade levels, the study of Geography and Economics are missing. The high school graduation requirements would need to be changed and the new graduation tracks will also be affected. Dual credit classes offered will not meet these new standards necessary for graduation. The number of CTE classes and electives would be affected because students would not have room in their schedule to take them. Lastly these standards lack depth of knowledge and critical thinking skills. When our school went through accreditation, one of the main focuses was depth of knowledge. We had to show rigor and dept of knowledge at various levels in our content and activities. These standards come off as a checklist of things that need to be covered and would not meet the accreditation criteria. We respectfully request that the committee review the public's opinions regarding these standards and revise them to address the stakeholders' concerns. Respectfully submi

between the two sets of standards difficult for students, teachers, and parents/guardians.

ask the State Board of Education Standards Commission request the

	Department of Education create a new workgroup that combines a portion of members from the 2021 and 2022 workgroups, as well as adding new members as needed for a new well-rounded workgroup that includes educators from all grade levels. The goal of the newly established workgroup should be a third set of proposed standards that would move forth for public comment, testimony, and final adoption.
Brookings School District	South Dakota teachers, administrators, and school board members from across the state made clear in public comment and testimony during the State Board of Education Standards hearings their serious concerns with the proposed Social Studies standards from the Social Studies Content Standards Commission. We, the Brookings School District school board, oppose the proposed Social Studies standards for the following reasons: Whereas: 1. The process of revising the Social Studies standards was done in a manner that did not consult the expertise of South Dakota educators in their development, as has been the practices for decades of standards revision; 2. The proposed Social Studies standards are not based on educational best practices, but rather are written as tasks, not standards; 3. Many of the proposed Social Studies standards are not age or developmentally appropriate for students, lack depth of knowledge, higher order thinking and do not address skill development; 4. The proposed standards would require excessive contact hours to teach to students, which would take time away from other curricular subject; 5. Current Social Studies materials used in schools do not align with the proposed Social Studies standards, which will result in new materials, teacher training and resources needing to be purchased at a high cost to schools. Therefore, we, the Brookings School Board respectfully ask the State Board of Education Standards request the Department of Education

reconvene the Social Studies workgroup from 2021, with instructions for

the workgroup to revise their draft with consideration of the Social Studies Content Standards Commission's proposal. The goal should be a third proposed set of standards as a compromise between the first two Social Studies content standards proposals to ensure school districts across South Dakota are best meeting the academic needs of
