Noem Opens 2020 Legislature with More Optimism About the State's Budget

Still No Commitment to Give Schools a Two-Percent Increase

The 2020 Legislative Session kicked off with Governor Noem's State of the State Address. The main takeaway from her hour-long speech: sales collections are up and that may mean more money for education. This was a more optimistic forecast than from her December budget address in which she proposed a zero percent increase for state aid to education. The question still remains; will the state keep its promise to the students of South Dakota and keep its education investment at pace with inflation?

To honor its commitment, the legislature must increase state aid by at least twopercent; anything less would mean that for the second time in four years, state-aid would fall short of keeping pace with growing expenses. Without that increase, students will have less access to school counselors, fewer career and technical education and fine arts programs, less one-on-one time with teachers, and fewer supports for students in need.

How can you get involved? First, make





sure you sign up for Lobby Line to get the latest developments from the state capitol. Watch for Action Alerts to raise your voice for students and public education. Attend a local legislative coffee or cracker barrel. Finally, support our students by signing up for Lobby Day scheduled for February 17 and 18. A New Year's Resolution for Your Students

A new year is a time for new resolutions. The usual ones include resolving to eat less, workout more, get more sleep, be more organized, be less stressed, and so on and so forth. Then the holiday break ends, and we head back to school where our students take most, if not all, of our attention. Our resolutions often fade, and we vow to be better with a resolution next year. What if we did something different and made this year's resolution about our students? What if we all resolved to stand up and fight for our students and their education?

In December, Governor Kristi Noem outlined her vision for the FY2021 budget. Unfortunately, her proposal freezes education funding for both K-12 and higher ed. When legislators increased the state sales tax by a half a penny and created the new funding formula, they also promised to continue to increase state funding by three percent or the rate of inflation, which ever is less, on a yearly basis. They said without yearly increases, even modest ones, the increase given that year would slowly be eroded over time. If legislators adopt Governor Noem's proposal, it would be the second time in less than four years that state leaders failed to keep their promise to the students of South Dakota. The erosion has already begun.

What can we do about it? The Governor's budget proposal is just the starting point. For the next two months, educators can stand up for students by engaging in a dialogue with their legislators who will have the final say on the state funding (increase or lack of) our schools receive. By talking to legislators about our students' needs, we paint a very important picture of what our students stand to lose without funding. Does it mean less access to a school counselor? Does it mean fewer career and technical education opportunities? Does it mean students will have less one-on-one time with their teachers? Look at your classrooms and schools. What tools and resources does your school need to give your students the best education possible? What will your students lose?

How do you keep this resolution? Pay attention. What are you hearing in the news? Have you signed up for Lobby Line? Are you following SDEA on Twitter and Facebook? Write a letter to your legislators. Tell them about your school and what a two-percent increase will mean for your students. Attend your local coffees and cracker barrels. These are the best opportunities for back-home one-on-one conversations. Finally, come to Pierre for SDEA's Lobby Day on February 17–18. Show that you are united with your fellow educators in this fight for our students.

Let's keep the resolution for the rest of the year. Let's keep the dialogue going. Invite legislators into your schools and classrooms to show first hand where the state's investment is going. Don't stop at the legislature. Be involved at the local level. Attend school board meetings. Get involved with local school board elections. Encourage supportive community members to run for office. Talk to your community leaders. Let them know about the needs of your school and students. Build relationships that endure.

If we all resolve to stand together for our students, we can offer them the world. This is my resolution...who's with me?

Thank you for everything you do for your students. They need you to be their advocate both in and outside the classroom. They need your voice. Thank you for using it on their behalf during this legislative session.

2020 Tri-State Summit: Creating Thriving Learning Environments for ALL Students

For those of you struggling unsuccessfully to resolve student behavior issues, mark your calendars for **Saturday, March 7**. SDEA is partnering with Nebraska State Education Association (NSEA) and Iowa State Education Association (ISEA) to host a joint summit on redefining the thriving classroom and addressing disruptive student behaviors with a change of approaches. The six-hour event will be held from **9am–3pm** at Northwest Area Education Agency, 1520 Morningside Avenue, Sioux City, Iowa 51106.

SDEA member voices have uniformly relayed consternation about changes which have occurred in student behaviors in recent years, along with reports that current classroom management strategies no longer work. Educators are seeing aggressive and defiant behaviors manifesting at a much earlier age. A growing number of students are displaying signs of dysregulation, or the inability to manage the intensity and duration of negative emotions such as fear, sadness, or anger. Recently, association staff from all three states discovered the problem is shared and has even resulted in assaults against educators. The conversation prompted SDEA, NSEA, and ISEA to pool resources and provide what we hope will be a rich conversation with teachers across the upper Great Plains featuring key note addresses from experts in child psychology and K12 education.

The summit will cost \$25 for members and \$50 for non-members and will include a luncheon and a 6-hour CEU certificate. Graduate credit options are pending through the University of Sioux Falls and Drake University but will require additional meeting time and work to comprise the 15 hours required for a graduate credit. Coffee Talk:

Meeting with your legislators at local coffees and cracker barrels



Legislative coffees or cracker barrels are a time-honored tradition that allow citizens to question local legislators on the issues of the day. Generally, local community service groups host these one to two-hour townhall meetings on Saturdays during the legislative session. This is prime back home access to your local legislators during the session. So, how should you get involved?

- **Don't go it alone:** Organize your colleagues and friends to attend with you. There is strength in numbers.
- **Do your homework:** Who is hosting the local coffee/cracker barrel? Local Chamber? Kiwanis? What are the format and rules?
- **Be Prepared:** Have questions prepared ahead of time. Know what you are going to ask.
- **Prioritize:** Time is limited. What is the most important question that you want to ask your legislators? Have more than one person prepared to ask or submit the same question to the moderator. This improves the odds that your questions will get answers
- **Be Respectful:** Respect the moderator and the time limits. Ask your question and allow the legislators to respond. Do not interrupt; even if you don't agree.
- Look Unified: This is a great opportunity for you to join the #RedforEd movement. Have everyone

wear the same color. Buttons or stickers are also a great way to look unified.

- **Be Social:** Live tweet any responses to education questions. Share photos of your group on Facebook and Instagram. Let others see you in action to inspire others to get active. Use #SDLeg or #SDLegCoffee so others can follow along.
- Follow Up: After the forum concludes take a moment to introduce yourself to the legislators or send an email. Ask them to clarify any answers you didn't understand.
- Host a Coffee: No legislative coffees in your community? Consider having your local host a coffee during the legislative session. Work with legislators to coordinate a weekend date.
- **Give Feedback:** You can help the SDEA Lobbyists by sharing what you are hearing from your local legislators. You can find the feedback form at sdea.org

ESP: Tips for a Successful Supervisor Meeting

Don't wait too long to schedule a meeting with your supervisor. Let him or her know that you know your job. If needed, ask clarifying questions. Periodically communicate with your supervisor throughout the school year.

Schedule adequate time. Allow yourself enough time to write notes and to discuss mutual concerns.

Meet at a convenient time and place for your supervisor.

If a job description has not been provided for your position, consider making up a fact sheet about your job description. This will clarify expectations.

Relax, smile, speak slowly, and don't be afraid to ask questions of your supervisor. If your supervisor is not able to answer a question, ask for help in getting an answer.

Set a positive tone. Open with a positive statement about your work and abilities. Wherever possible during the conference, include good news about your job experiences. Focus on your strengths and frame any difficulties as "areas of need." **Be specific.** When commenting on positive or negative aspects of your position, use specific examples of what you know or have experienced. Don't refer to any rumors.

Ask for your supervisor's opinions. He or she may have ideas about your job or may have worked in your position at one time.

Stress cooperation. Let your supervisor know that you want to work together to help the district. Listen to concerns and design approaches that meet your supervisor's needs, your needs and, most importantly, the district's needs.

End on a positive note. End the conference on a positive note, summarizing the actions that you will take. Offer to meet again. Be sure to thank your supervisor for his/her time.

Keep a record of the meeting. Keep notes that summarize your conversations. Include specific suggestions for improvement that were discussed during the conference. Consider making copies of notes made and actions agreed upon during the conference so that your supervisor also has a clear record of your activity.
