First, if you are interested in serving on the SDEA Board of Directors or becoming a NEA RA delegate, you need to let me know your intentions by January 15, 2024. You can find more information on running for one of these elected positions in this publication and on our website at sdea.org. You should also mark your calendars for the SDEA Lobby Day, February 25-26, 2024. This will be a great opportunity to raise your voice with legislators for public education.

Finally, I want to thank you for the work that you do every day. You truly make a difference in the lives of students.

## **Get to Know George Hawkins**

### 2024 South Dakota Teacher of the Year



Meet the 2024 South Dakota Teacher of the Year: George Hawkins, a social studies teacher at Jefferson High School in Sioux Falls. George, who is in his 12th year of teaching, did not follow a traditional path to the classroom. Prior to finding his way to the school building he was a practicing attorney. Now, he shares his love of history and civics through project-based learning. SDEA had the opportunity to spend an afternoon in George's classroom where his ability to masterfully engage students was on full display. Whether the topic was

fiscal policy or oil trusts, it was abundantly clear why students loved to be in Mr. Hawkins' class. George took time out of his busy schedule to answer some questions to help our readers get to know the 2024 Teacher of the Year.

## Tell us more about you — hometown, family, education...anything you want your fellow SDEA members to know?

I grew up in Watertown, SD after moving there when I was three years old; we moved due to my father's work, but he soon took a job at Lake Area Tech. I had a stay-athome mom who instilled the values of hard work, loyalty, and caring for others in me and my two older sisters. I graduated from Watertown High School in '99 and eventually received my Bachelor's degree from Augustana College (now University) in 2004. I pursued my teaching certificate but instead went to the USD School of Law and received my Juris Doctorate. Having come back to the teaching profession I became the 2016 James Madison Fellow for South Dakota, which allowed me to obtain a Master's degree from Ashland University in American History and Government.

## What was your initial thought when you heard your name announced as the South Dakota Teacher of the Year?

Pure shock. I felt that the other finalists were tremendous representatives of our teaching profession and thus one of them was going to be selected. It didn't feel real then, and it doesn't feel real even now.

## What are you most looking forward to over the next year?

Getting to meet and know the other states' Teacher of the Year. From what Alyssa has said, this is the best year of professional development. I'm interested in learning from others and then bringing it back to the classroom to make a better classroom for my students.

## What do you see as some of the greatest challenges facing public school educators and students in the coming years?

Teacher shortages and burnout. Educators are a vitally important component of our

educational system and school districts are facing issues regarding a lack of adult bodies to fill the necessary roles to make schools function effectively.



## What advice do you have for teachers who are just entering the profession?

Make time for yourself. You'll be overwhelmed at times and make sure to connect with friends and family or whatever keeps you grounded and refreshed.

## Is there something your students know about you that others may not?

I studied abroad in China for a semester while an undergrad student.



#### Best method of self-care?

Relaxing night with family or friends.



## What is the one lesson you hope that students take from your class?

They are capable of much more than they think they are capable of. Many times, students get stuck believing that they cannot because they haven't done it before. Sometimes it just takes a small accomplishment for students to see that there is more to them than they thought.

#### Any parting words of wisdom?

As Minor Meyers said, "Go into the world and do well. But more importability, go into the world and do good."

Hawkins will go on to represent South Dakota in the National Teacher of the Year award ceremony in Washington D.C. next spring. As an SDEA member, George also received a\$1000 SDEA Innovation Grant.

## South Dakota's Public Schools Prepare for Voucher Fight

As more and more states pass school voucher programs, it comes as no surprise that some South Dakota lawmakers are eyeing legislation to do the same when they come back to Pierre in January. So, what exactly would a voucher program mean for South Dakota's schools and students?

Vouchers take scarce funding from students in public schools and give those resources to unaccountable private schools. The Legislative Research Council estimated that a voucher program would cost taxpayers over \$45 million. Often veiled as "parent choices", vouchers programs allow private schools to use taxpayer dollars to pick and choose which students they want to educate.

No matter how you look at it, vouchers undermine strong public education and student opportunity. **They take scarce funding from public schools**—which serve 94 percent of students of South Dakota's students—and give it to private schools—institutions that are not accountable to taxpayers.

This means public school students have less access to the supports students deserve. Voucher programs will severely limit public schools' ability to offer programs such as art and music or provide up-to-date technology and textbooks. Vouchers will especially hurt our more rural schools where private schools don't even exist.

Moreover, there is **ZERO statistical** significance that voucher programs improve overall student success, and



some programs have even shown to have a NEGATIVE effect for students receiving a voucher.

Furthermore, vouchers have been shown to not support students with disabilities, they fail to protect the human and civil rights of students, and they exacerbate segregation.

## **SDEA Reapportionment**

Every three years SDEA has to go through a reapportionment process to balance out its governance and UniServ Staffing units. During this process the committee works to ensure that each member has equal voice through their voting rights in the organization. As part of the results of the process, some of our local affiliates will change which unit they belong to in order to achieve that balance and this will also impact which UniServ Director that they work with. If you are interested in running for an SDEA Board or officer position, you will be running for those positions in your new unit since the changes officially take effect **July 15th, 2024**. The units that will be affected by these changes are Eastern Prairie, SEE, and EGL. As a reminder, the deadline for candidacy forms for governance positions is due on **January 15th, 2024**.


In this election, the new lines only apply to Board positions. If you would like to run to be a delegate to the NEA RA, you will run for that position from your current unit.




Scan this code to see the new SDEA Governance map that takes effect **July 15th, 2024**.

#### **GRANT, SCHOLARSHIPS, CAREER**



#### **SDEA/NEA Early Career Educator Award**

An individual member or a local may nominate an early career educator for this award. Each governance unit may select an Early Career Educator of the Year from nominations submitted in their unit. All the unit winners will be candidates for the statewide award, which will be announced at the 2024 Representative Assembly in Pierre.

**Deadline:** December 1



#### **Gordon Horgen Memorial Scholarship**

The South Dakota Education Association/NEA is calling for applications for the Gordon Horgen Memorial Scholarship, which is awarded to Native American students who are planning on entering the teaching profession. This scholarship was created by the 2014 Representative Assembly to honor the late Gordon Horgen from Winner.

The Association may annually award up to four \$750 scholarships for each academic year. The scholarships are open to Native American high school seniors or college sophomores who are planning to enter the teaching profession.

#### Ramia Boersma Scholarship

The South Dakota Education Association/NEA awards scholarships to outstanding students who are planning on entering the teaching profession. The Association may annually award up to three \$750 scholarships for each academic year.

#### **SDEA/NEA Educational Innovation Grant**

The SDEA/NEA Educational Innovation Grant Program provides grants to members in support of innovative educational and student-oriented projects. The grant program funds new member-led projects. It does not fund projects on an on-going basis. The SDEA/NEA Educational Innovation Grants give preference to proposals that address student achievement, cultural diversity issues, include community partnerships, and can be duplicated by others.

# Answering Questions About Your Union

## Someone's Filed a Complaint... Now what?

Parental involvement is a vital part of student success. A good working relationship with parents must include open communication and a mutual respect for each other's roles in a student's life. However, the current political climate is putting a strain on the parent and teacher relationship.

School districts around the state are seeing an uptick in complaints against educators, which are often in response to groups like Moms for Liberty spreading disinformation on the internet. So, what should you do if one is leveled against you or your colleagues?

Here are the six things you should do if a complaint is aimed at you:

- 1. Review and understand your district's complaint policies and procedures. If you are not aware of any policies consult your local union representative or leaders.
- **2. Contact your Uniserv Director**. They are here to help you. It's better to consult with them at the beginning of a situation.



- 3. Insist that administrators follow the district's complaint policies and procedures. This may require a meeting between you and the parents to try and resolve the situation.
- **4. Do not post or respond** to any social media conversations regarding the situation.



- **5. Document everything!** This is important if the situation escalates.
- **6. Keep your administrator informed** of any interactions you have with the parent or parents. This ensures they know both sides of the story.

Stay focused on the positives. Remember most parents want to work with you to ensure their students' success, but when a situation arises make sure you seek the support of your local association and Unisery Director.

#### The More You know...

We continue our series highlighting the lingo of the Association to help our members better understand the work we do. Here are five more words that come up in conversations about your union:

**GRIEVANCE:** Generally, a violation of the collective bargaining agreement where a formal written complaint is filed with the employer by the grievant (employee or association). Grievance procedures are negotiated and included in the collective bargaining agreement. If unable to resolve at an early step in the process, the dispute is typically resolved with the SD Department of Labor.

#### **DUTY OF FAIR REPRESENTATION (DFR):**

In states with a collective bargaining statute, it is the legal responsibility of the union (or association) to represent all members of the bargaining unit in collective

bargaining and grievances, not just its dues paying members.

REPRESENTATIVE ASSEMBLY (OR RA): The annual meeting where elected delegates vote to decide the policy and priorities, and give input on the budget of the union. This may also be called a convention in some unions.

**COLLECTIVE BARGAINING AGREEMENT (OR CONTRACT):** The resulting legal, binding agreement that codifies the language that was agreed upon in collective bargaining. It becomes effective after union members ratify the tentative agreement.

**MEMORANDUM OF UNDERSTANDING** (MOU): A signed agreement that can be either a stand-alone agreement or a supplement to the existing collective bargaining agreement. Such an agreement can also be referred to as a memorandum of agreement (MOA).


