Get to Know Amy Verhelst

2025 South Dakota Teacher of the Year and 2025 SDEA Teacher of Excellence

Let's meet Amy Verhelst, the 2025 South Dakota Teacher of the Year and SDEA Teacher of Excellence. Amy took some time out of her busy schedule to share her thoughts on the greatest challenges facing public school educators, including the pressing literacy crisis, and offers valuable advice for new teachers entering the profession. She emphasizes the importance of building relationships, maintaining a work-life balance, and fostering a growth mindset in students. Amy also reveals a fun classroom tradition that her students love and discusses her approach to self-care. Let's get to know Amy:

Tell us more about you—hometown, family, education...anything you want your fellow SDEA members to know?

I grew up in the small town of Parkston, South Dakota. From 2007 to 2014, I served in the Army National Guard with the 153rd Engineer Battalion, the unit based in my hometown. After graduating from Parkston High School in 2009, I attended South Dakota State University, where I earned my bachelor's degree in early childhood education with a Kindergarten endorsement. My first teaching job was at Brandon Elementary as a Junior Kindergarten teacher. The following year, I discovered my true passion—teaching Kindergarten. I then had the opportunity to teach Kindergarten for two and a half years in Brownsburg, Indiana.

My husband's job eventually brought us back to South Dakota and we settled in Brookings, where we had met. During my first few months in Brookings, I substituted in the school district and worked as a long-term teacher assistant in the Early Childhood Program. In the fall of 2019, I started my current position as a Kindergarten teacher in Volga, SD.



Growing up, my family has always placed a strong emphasis on community and education. My father, Leonard Nolz, served in the military for 39 years, and my mother, Deb Nolz, worked in various school districts as a secretary and special education assistant. All my siblings have continued this tradition—my brother Tyler is a high school teacher and wrestling coach, my brother Brady is a wrestling and baseball coach, and my younger sister Tanna works as an elementary behavioral technician.

My husband, Jon, and I currently live in Brookings. We have two children, Cameron (4) and Luke (2), and another baby on the way in February!

What was your initial thought when you heard your name announced as the South Dakota Teacher of the Year?



I felt an overwhelming sense of relief and gratitude. I had hoped for this moment, not just for the recognition but for the opportunity it brings to share my passion for teaching

and advocate for students and educators. This platform means so much to me, and I'm honored to represent our profession in this way.

What are you most looking forward to over the next year?

I'm looking forward to engaging with future educators, building strong networks, and participating in leadership and learning opportunities. What excites me the most, however, are the state's initiatives to improve literacy. I'm especially eager to advocate for changes grounded in the Science of Reading and support efforts to ensure all students have access to effective literacy instruction.

What do you see as some of the greatest challenges facing public school educators and students in the coming years?

The public education system faces many substantial issues, but none as pressing as the literacy crisis. Without the ability to read. individuals encounter obstacles in all aspects of life, hindering their potential for success and well-being. Literacy is the first domino in a chain reaction of detrimental consequences, leading to mental health struggles, low test scores, high dropout rates, increased poverty, and a growing prison population. By advocating for evidencebased curricula, raising awareness about dyslexia, and prioritizing teacher training, we can create a future where all students become proficient readers and have the opportunity to lead successful lives.

What advice do you have for teachers who are just entering the profession?

I think new teachers are coming into the profession at an exciting time for education. There are going to be many challenges ahead and finding a work life balance will be hard at first. Find your person or team that will support you at school and to help you grow as a teacher. Be curious and ask lots of questions. Building relationships trumps all when setting up your classroom.

Is there something your students know about you that others may not?

If you've been a student in my class over the past 11 years, you'll know that every October, I reveal my true identity: I'm actually a real witch (a good witch of course), and my other job is to be a teacher for the rest of the year. I attended "Witch University" with my friend Hilda, a motion-sensor hanging witch, who comes to visit our classroom the week of Halloween. She knows kids can get a little wild during this time, so she's there to help me out and keep an eye on the kids. On Halloween Day, I arrive in full witch costume,

Answering Questions About Your Union

Fact Finding — How One Local Used the Process to Build Support

The West Central Education Association (WCEA) negotiation team faced a challenging bargaining season with the school district. The district's proposal to cap unused sick leave at 45 days without compensating those with balances exceeding this cap was a significant point of contention. Under the current contract, employees could bank an unlimited number of sick leave days, and many had balances well over 45 days, with some exceeding 200 days or more.



The SDEA sat down with the negotiations team including Connie Schumacher, Nancy Shade, Matt Evans and Ashley Payne to talk about the experience and the team made it clear that this negotiation process would be much different than previous negotiations.

The two sides exchanged proposals just before spring break. While WCEA presented four proposals, the district came with a hefty 36-page document, including the controversial sick leave cap. Additionally, the district wanted to consecutively enforce the six weeks of parental leave, preventing new mothers and fathers from splitting their leave to accommodate family needs.

Determined to fight for their members, the WCEA team decided to push back. The board remained firm despite only three bargaining sessions and quickly declared an impasse. The next step was mediation, but after a brief and unproductive session, the team faced a tough decision: accept the board's imposition or move to Fact Finding with the South Dakota Department of Labor.

Fact Finding in South Dakota is non-binding, and the administrative law judge does not provide a rationale for their decision, simply siding with either the board or the association. Despite the odds, the WCEA team decided to proceed, driven by their members' encouragement and a desire to show the board they wouldn't back down.

Fact-finding in South Dakota can be dubious because an administrative law judge's decision is not binding and does not provide any rationale. More often than not, school districts just impose their will on their employees for the next year and meet back at the table for more negotiations in the spring, but for this team, going through the process was about standing up for the members.

"Going through the process was very important. I mean, to so radically reshape our leave," said Schumacher. "We couldn't leave it unanswered, and membership wanted us to do it."

The hearing took place in late summer in Pierre and focused on six key issues, including the sick leave cap and parental leave. Both sides presented their cases, and then the waiting began. Historically, administrative law judges in South Dakota tend to side with school districts, making it an uphill battle for WCEA.

When the decision finally came, the judge sided with WCEA on three issues. Although it was a moral victory, the board still imposed its language on two issues. However, strategic social media posts by a community member informing parents and community members about what was going on put enough pressure on the school board to reconsider the sick leave bank.

The board hastily called a meeting with minimal public notice, but WCEA quickly mobilized its members and the community. Initially planned for a small conference room, the meeting had to be moved to the gymnasium due to the overwhelming turnout of teachers and community members, a clear testament to the unwavering support for WCEA.

After an executive session, the board made some concessions. They increased the sick leave cap to 60 days and allowed those with over 100 days to retain their balance up to 100 days. However, teachers with balances between 60 and 100 days were still at a loss. The board did agree to put half of the days they took away from staff into the sick leave bank, but it also imposed the other two contested items.

While it was a small victory, the board's decision still meant some teachers lost leave without compensation. Nevertheless, the WCEA team saw it as a starting point for future negotiations. The imposed contract could only be enforced for one year, giving WCEA another opportunity to negotiate in the spring.

The fact-finding process, though frustrating, demonstrated WCEA's commitment to fighting for its members. It sent a clear message to the board that WCEA would not back down and showed the district that the community supported the teachers. These factors strengthen WCEA's position for future negotiations.

The critical lessons learned were that fact-finding is not just about winning a decision but about standing up for members and showing the district the association's resolve. Engaging with the media early in the process ensured the community was informed and supportive, which was crucial in applying pressure on the board.

While the team said it was an exhausting process, they all agreed that it comes down to standing up for the members and showing the value of being a member of WCEA. "We did gain some members through this process just because we were visible. It showed what we do and how we try to advocate for members," said Schumacher. "Going through it shows that you're willing to stand up to your administration, and it shows the value to your members that you are willing to fight for them."

and my students help me make a 'witch's brew' potion with dry ice and other creepy ingredients. This brew is said to protect them for up to 10 years on Halloween night!

This tradition has been part of my classroom for years, and former students still come back to ask when Hilda will return or if they can get more of the 'witch's brew'. I cherish these magical memories from my elementary school days, and I love creating similar experiences for my students.

Best method of self-care?

The best form of self-care is maintaining open communication with those who support and care about you. Surrounding yourself with a positive circle, both at school and outside the classroom, is crucial. I firmly believe that social-emotional learning for educators can have a huge impact on your ability to be your best for your students, remain resilient when facing challenges, and ultimately lead a happier, more balanced life at school and home. For me, self-care involves listening to audiobooks and podcasts, and connecting with colleagues, friends, and family.

What is the one lesson you hope that students take from your class?

The most important lesson I want my students to learn is that they are capable

of amazing things. I work hard to instill a growth mindset. I also prioritize building their resilience, so they know setbacks are opportunities to grow, not reasons to give up. I want my students to believe in themselves and their potential. With the right mindset and effort, there's no limit to what they can achieve.

Any parting words of wisdom?

One of my favorite quotes is from Maya Angelou, "Do the best you can until you know better. Then when you know better, do better." The more knowledge you have about your students and their social and academic needs the better equipped you will be to support and uplift them on their educational journey.

SDEA President Loren Paul presented Amy in October with the 2025 SDEA/ NEA Foundation Teacher of Excellence Award. This award, jointly presented by the NEA Foundation and SDEA, recognizes outstanding teaching and advocacy. Amy will receive a \$1,000 grant from SDEA and a trip to the NEA Foundation's 2023 Salute to Excellence in Education Gala in Washington, DC. Additionally, five awardees will be selected for The Horace Mann Awards for Teaching Excellence, each receiving \$10,000, with one recipient earning the NEA Member Benefits Award for Teaching Excellence and \$25,000.



Scholarship funds will be awarded to the college or university the student enrolled in before the start of the fall semester, provided all criteria are met.

Aberdeen Education Association's Kerry Konda Wins National Award!




Happy Thanksgiving! Merry Christmas! Happy Holidays! It's hard to believe that another year is nearly over.
